- Outdoor booth space is 10'x10'. You are responsible for supplying tents, tables and chairs and your own source of power for your booth.
- Cancellation Policy:
 - Full refunds will be processed on cancellations received no later than May 1, 2009.
 - Cancellations received after May 1, 2009 will be subject to a \$10.00 handling fee.
 - No refund will be processed on cancellations received the week prior to the festival.
 - No refunds will be issued due to inclement weather on the day of the festival.
- Only items that are handcrafted or of retail quality can be sold at this festival. Items shown or sold of "yard sale" quality are not allowed.
- **FOOD VENDORS:** A Gaston County Application for Temporary Food Establishment Permit must be sent along with your application by **May 15, 2009 – NO EXCEPTIONS.** The Gaston County Environmental Health Division also requires a \$50.00 "Temporary Food Establishment" permit fee

- for each event. The Gaston County Environmental Health Division will contact you to pay this fee.
- All booth space applications are reviewed by The Lowell Recreation Department and The Lowell Women’s Club to determine acceptance to the festival. If your application is rejected, your money will be fully refunded prior to May 22, 2009.
 - Registrations must be received no later than May 15, 2009. Make checks payable to The Lowell Women’s Club. Our mailing address is:

 - Your exhibit area must be cleaned and cleared by 8:00pm on May 30, 2009. ***The exception to this is if you are staying open during the live stage show entertainment (5pm to 10pm). If this is the case, your area must be cleaned by 10:30pm.***
